The Children's Advocacy Center of the Bluegrass is a quiet treasure in Central Kentucky – a place where courageous children and young people, victims of child sexual abuse, can gain the strength they need to rebuild their lives.

Our Center is a refuge for families confronting the reality of child sexual abuse. In 2011 alone, 586 child victims and 781 caregivers passed through our doors. That's why we are moving to a larger facility and why we are seeking your help with a one-time gift to our Capital Campaign.

One out of four girls and one out of six boys will suffer the horror of child sexual abuse before their 18th birthdays, often preyed upon by a family member or trusted family friend. The Children's Advocacy Center provides therapy, crisis counseling, medical exams and forensic interviews at no cost to child victims or their families. Hope and healing are available to all.

We cannot change what has happened to a child, but we can change what happens next. With your financial support, we can and will do more. Thank you for your consideration and support for our Capital Campaign.

## our STORY

For a child who has been sexually abused, nothing is more terrifying than the thought of telling someone what has happened to them. Because most children know their abuser, they understand that their disclosure will forever alter life as they know it.

The criminal justice system — originally designed for adult defendants, not child victims — made it even more difficult for children to talk about their abuse. Children with the courage to tell what had happened to them were forced to undergo repeated questioning about the most traumatic event in their lives. They were interviewed and examined numerous times by police, medical providers, and social workers.

Despite the best efforts of these dedicated professionals, they were re-traumatizing the very children they were trying to help.

The Children's Advocacy Center of the Bluegrass was established to coordinate the investigation, prosecution, and treatment of child sexual abuse cases across 17 Central Kentucky counties. Modeled on the simple but powerful concept of coordination between professionals involved in the system, the Center preserves the dignity of child victims, maintains their trust, and ensures their best interests remain at the heart of every criminal investigation.

Each year, nearly 600 children come to the Children's Advocacy Center to receive forensic interviews, comprehensive medical examinations, counseling and advocacy support. All services are provided in a nurturing, friendly and safe environment at no cost to a child's family. The Children's Advocacy Center of the Bluegrass serves the 17 Central Kentucky counties: Anderson, Bourbon, Boyle, Clark, Estill, Fayette, Franklin, Garrard, Harrison, Jessamine, Lincoln, Madison, Mercer, Nicholas, Powell, Scott and Woodford counties.

#### our current HOME

In 1994, we opened our doors at 183 Walton Avenue, a beautiful Victorian home just east of downtown Lexington. Since that time, thousands of children have found safety and security within the walls of the Children's Advocacy Center. Some discovered a place where it was finally safe to tell their story. Other children remember this house as the place where they learned to trust again and started to heal.

We outgrew our little house on Walton Avenue years ago and can no longer accommodate the growing demand for services.

- With only one interview room and waiting area on site, we are forced to limit the number of children we see each day.
- The interview room is not soundproof and children are often interrupted by the conversations of others waiting for services or street noise from Walton Avenue.
- There is limited space for parents to consult privately with Center staff and receive the care, support and attention they need.
- The Center's observation room used by law enforcement and social workers to monitor forensic interviews – also serves as our conference room.
- When a meeting of any kind is held on site, forensic interviews cannot be conducted.

In 2011, we provided services to a record 586 children and 781 caregivers. Dur current facility can no longer accommodate the increasing number of children who need our services.

### our VISION

We believe that all child victims of sexual abuse in Central Kentucky deserve access to the caring and compassionate services provided at the Children's Advocacy Center of the Bluegrass. A new facility is essential to facilitate the collaborative work of our partners and provide hope and healing to every child victim.

Children

who visit our Center should experience a nurturing, safe and child-friendly environment; a place where they can ask questions, explore complex emotions and feel supported as they begin the process of healing.

# our FUTURE HOME



- 8,043 sq. ft. more than doubles the size of the existing Center and provides room to grow and expand services
- Centrally located near the heart of downtown, Mentelle Park is an established, quiet, and safe neighborhood that is easily accessible for families and our community partners
- Three separate parent waiting areas will provide privacy and comfort for children and families visiting the Center
- Dedicated space for individual, group and family counseling, as well as weekly parent and child support groups
- A private, client intake room will provide a safe place for parents to ask questions and express concerns about the investigation
- Multiple soundproof, Forensic Interview rooms and adjoining observation rooms for investigators will allow for simultaneous interviews, reducing wait time for children and their families
- On-site, child-friendly Medical Clinic will provide compassionate care to those in need of specialized medical attention
- State-of-the-art Learning Center will provide space for training professionals and community members about child sexual abuse
- Private playground for children visiting the Center
- Administrative workspace separate from client activity
- Ample parking for parents, law enforcement, social workers and staff
- Large file room with workspace and abundant storage space


