For more than 20 years, the Children's Advocacy Center of the Bluegrass has provided hope and healing to children and families struggling to overcome the pain of sexual abuse. We were founded by a small group of committed citizens determined to improve the way our community supports our smallest, most vulnerable victims of crime. Their early leadership transformed a broken system and helped to make life safer for thousands of children in Central Kentucky.

Each day we witness the beautiful transformation from *Victim to Survivor to Thriver*. This is exactly the reason I tell people that I'm proud to work at the Children's Advocacy Center.



A Record Breaking 2014

After moving into our new facility in March 2013, requests for our services have skyrocketed. Our beautiful, new home ensures we can now serve more children than ever before.

In 2014 the Children's Advocacy Center of the Bluegrass:

- Conducted 621 developmentally-sensitive Forensic Interviews
- Provided over 600 crisis counseling, support groups, and case management
- Conducted over 150 medical examinations to diagnose and treat injury, collect forensic evidence, and provide reassurance to every child and family
- Provided trauma-focused therapy services to promote emotional healing for 85 children

CACs Save Money

The CAC model saves court, child protection, and investigative dollars averaging \$1,000 per child abuse case in direct costs alone.

Our Programs and People

The CAC's Regional Presence

In 2015, more than 700 children from 17 Central Kentucky counties will come to the Center to receive forensic interviews, medical examinations, therapy, and advocacy support. The Children's Advocacy Center of the Bluegrass is the largest regional children's advocacy center in the state of Kentucky. Requests for all services have grown nearly 70% since 2010!

Our Core Services

Forensic Interviewing takes place at the request of law enforcement when allegations of abuse surface. Specially trained CAC staff members interview children to collect details of the crime in a developmentally-appropriate way. These interviews take place in one of two, child-friendly and comfortably furnished interview rooms - one for young children and one for adolescents and teens. These interviews follow a legally-defensible, best practice protocol and all interviews are recorded and preserved on DVD. According to Fayette Commonwealth's Attorney Ray Larson, conviction rates for child sexual abuse cases in Fayette County have increased from approximately 5% to over 95% in the 21 years the Children's Advocacy Center of the Bluegrass has been in operation.

Medical Examinations take place in our brightly colored, child-friendly clinic located on site. All exams are conducted by a board-certified child abuse pediatrician, the only one in our area. Exams are conducted to identify and treat injury, collect forensic evidence, and screen for other health conditions. In addition to the sexual abuse medical exam, our physician performs a full well-child examination and a mental health screening is conducted to assess each child's emotional well-being and identify treatment needs. Every child leaves with a handmade blanket and stuffed animal. Above all, we find that medical exams provide reassurance and peace of mind to children and their families.

Family Advocacy encompasses the broad array of support services designed to help families understand the dynamics of abuse and navigate the legal process. This includes crisis counseling, support groups, and case management services. Our family advocates work closely with caregivers to ensure our services meet every family's unique needs. Our family advocates provide more than 700 individual crisis counseling sessions and field over 400 crisis calls annually. Our goal is to ensure that families are linked with vital resources so they can be fully engaged in their child's recovery from the trauma of sexual abuse.

Our **Therapy Program** utilizes trauma-informed counseling to promote emotional healing after abuse. We offer individual, group, and family therapy to child victims, siblings, and caregivers. Therapy serves to increase a child's coping skills, help them process and heal from traumatic thoughts, and improve their capacity for safety. Ultimately, our therapy program's aim is to reduce the recurrence of abuse and allow children to grow into the happy, healthy, productive adults they were meant to be.
